- i) taking part in any contest or competition organised by British Weight Lifters Association Ltd
- ii) taking part in training organised by British Weight Lifters Association Ltd or Insured Person's club under the supervision of an instructor or official of British Weight Lifters Association Ltd or Insured Person's Club or
- iii) travelling directly to or from, other than by air or motorcycle, any contest of competition within Great Britain organised by British Weight Lifters Association Ltd
- iv) Travelling to or from any contest or competition held outside Great Britain.
